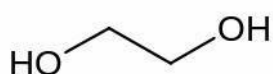

## SECTION 4: First aid measures

### 4.1. Description of first aid measures

First-aid measures general	: Check the vital functions. Unconscious: maintain adequate airway and respiration. Respiratory arrest: artificial respiration or oxygen. Cardiac arrest: perform resuscitation. Victim conscious with laboured breathing: half-seated. Victim in shock: on his back with legs slightly raised. Vomiting: prevent asphyxia/aspiration pneumonia. Prevent cooling by covering the victim (no warming up). Keep watching the victim. Give psychological aid. Keep the victim calm, avoid physical strain. Depending on the victim's condition: doctor/hospital.
First-aid measures after inhalation	: Remove the victim into fresh air. Respiratory problems: consult a doctor/medical service.
First-aid measures after skin contact	: Rinse with water. Soap may be used. Remove clothing before washing. Take victim to a doctor if irritation persists.
First-aid measures after eye contact	: Rinse with water. Do not apply neutralizing agents. Take victim to an ophthalmologist if irritation persists.
First-aid measures after ingestion	: Rinse mouth with water. Immediately after ingestion: give lots of water to drink. Victim is fully conscious: immediately induce vomiting. Induce vomiting by giving a 0.9 % saline solution. Give activated charcoal. Consult a doctor/medical service if you feel unwell. Call Poison Information Centre ( <a href="http://www.big.be/antigif.htm">www.big.be/antigif.htm</a> ). Ingestion of large quantities: immediately to hospital. Doctor: administration of chemical antidote. Doctor: gastric lavage.

### 4.2. Most important symptoms and effects, both acute and delayed

### SECTION 5: Fire-fighting measures

#### 5.1. Extinguishing media

- Suitable extinguishing media : Water spray. Polyvalent foam. Alcohol-resistant foam. Polymer foam. BC powder. Carbon dioxide.
